## Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all, sharing. Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Our joint marketing partners include insurance and other financial companies.
